Investing in Young People

We support organisations at different stages of development to improve, consolidate and spread practices that empower young people to shape their lives and lead change.

Youth Strategic Investment Fund

The Youth Strategic Investment Fund supports the development, sustainability and impact of organisations that have evidenced a track record of working with young people to achieve positive change.

Children's Law Centre

Grant amount: £500,000

Grant duration: 60 months

Location: Northern Ireland

Project: Youth Strategic Investment Fund

Description: The Children's Law Centre (CLC) is a national charity based in Belfast which empowers children and young people. This grant provides core funding to support organisational development and growth plans to enable CLC to uphold children and young people's rights, ensuring they can participate, are valued, their rights are respected and guaranteed without discrimination, and every child can achieve their full potential.

Empire Fighting Chance

Grant amount: £500,000

Grant duration: 60 months

Location: South West, Wales

Project: Youth Strategic Investment Fund

Description: Empire Fighting Chance uses non-contact boxing and intensive individual support to inspire young people experiencing disadvantage to make positive changes in their lives and improve their mental health. This grant provides core funding to support organisational development and growth plans, and to scale work harnessing the power of non-contact boxing to mentor, provide therapy and offer careers support for young people to change their lives.

Football Beyond Borders

Grant amount: £500,000

Grant duration: 60 months

Location: London, North West, South East

Project: Youth Strategic Investment Fund

Description: Football Beyond Borders uses football to support marginalised young people to raise attainment and aspirations. This grant provides core funding to support

organisational development and growth plans, and to scale work providing long-term, intensive support, built around relationships and young people's passions, so they thrive in the classroom and beyond.

Gloucestershire Young Carers

Grant amount: £500,000

Grant duration: 60 months

Location: South West

Project: Youth Strategic Investment Fund

Description: Gloucestershire Young Carers works with children and young people with a caring responsibility for a family member. This grant provides core funding to support organisational development and growth plans, and to support young carers to build on their strengths, achieve their aspirations and experience a positive transition to adulthood.

MAP (Mancroft Advice Project)

Grant amount: £100,000

Grant duration: 12 months

Location: East of England

Project: Achieving youth driven and led growth in service delivery and influence

Description: MAP is an established youth organisation, delivering across Norfolk and supporting 11-25 year olds, to make a successful transition to adulthood, through advice, counselling and youth work. This grant provides additional core funding alongside an annual package of support towards organisational innovation, development and growth. Investment will achieve youth driven and led growth in service delivery and influence.

A joint initiative between Paul Hamlyn Foundation and Esmée Fairbairn Foundation in partnership with The National Lottery Community Fund, both foundations are acting as match funders and are awarding grants on behalf of the #iwill Fund.

My Life My Say

Grant amount: £1,500

Grant duration: 14 months

Location: UK Wide

Project: Groundbreaker Fellowship

Description: My Life My Say is a youth-led charity that empowers young people to participate in democracy. This grant supports the continued development of the Groundbreaker Fellowship programme, which provides training sessions in mobilisation, public speaking, fundraising, media/communications and branding to young people who want to lead change.

Newport Mind

Grant amount: £19,500

Project: #Changelt campaign: social action through public sector engagement

Description: Newport Mind provides support services for adults and young people who experience mental health problems. This grant supports the hiring of a Service Development Worker to work with young people to lead the #Changelt campaign delivering training to professionals to improve their awareness and professional practices.

Phoenix Education

Grant amount: £20,000

Grant duration: 14 months

Location: East of England, East Midlands, London, South West

Project: Change Makers Lab: Developing agency, igniting activism, building communities

Description: Phoenix Education supports young people to lead change and facilitates collaborative decision making between schools, colleges and their communities. This grant supports the organisation's Student Voice and Refugee Support Network to engage young change makers in designing, planning and delivering their own social action projects that will improve young people's experience of the education sector.

RECLAIM

Grant amount: £20,000

Grant duration: 14 months

Location: North West

Project: Working Class Young People: Being seen, being heard, leading change

Description: RECLAIM supports young working-class people living in Greater Manchester to lead change in the systems that limit working class young people's opportunities. This grant supports young people to campaign nationally and locally around issues of discrimination, inequality and stigmatisation arising from unfair economic and political systems.

The 4Front Project

Grant amount: £20,000

Grant duration: 14 months

Location: London, North West, West Midlands

Project: Building the capacity of young activists

Description: The 4Front Project is a member-led youth organisation empowering young people and communities to fight for justice, peace and freedom. They support members with experiences of violence and the criminal justice system to create change in their own lives, communities and society. This grant supports resource provision for the youth-led 4Mation campaign and the 4Mation Peace Fellowship, which builds the capacity of young activists to lead campaigns.

West End Women and Girls Centre

Grant amount: £1,500

Grant duration: 14 months

Location: North East

Project: Power Up: Mobilising young women in the North East

Description: West End Women and Girls empowers women and girls who have been traditionally denied their rights to access existing services and effect positive change in their environment. This grant supports a peer education project to mobilise young working-class women with lived experience of gender inequality to build local campaigns, harness their

collective power, change policy and legislation to create better gender equality for young women in the North East.

Migration and Integration

We want to support young people who migrate, and strengthen integration so that communities can live well together. Our funding seeks to help organisations to address exclusion, deepen connections and build 'shared ground' that can lead to a more socially equal society.

Shared Ground Fund

The Shared Ground Fund supports organisations working to influence migration system reform, improve access to support services, strengthen civic participation and inform public understanding.

Act Build Change

Grant amount: £58,000

Grant duration: 18 months

Location: UK Wide

Project: Caring for Ourselves and Each Other

Description: Act Build Change supports people and organisations to build power, develop leadership and care for relationships. They aim to make community organising accessible to all and build a network of leaders committed to justice. This grant enables Act Build Change to develop a programme of collective training shaped by and for the migration sector. This training focuses on three key areas: development of training offer and staffing; fostering clarity of approach via research and collaboration; and organisational development.

City of Sanctuary UK

Grant amount: £220,000

Grant duration: 48 months

Project: Building a welcoming migration movement

Description: City of Sanctuary UK is a growing network of groups, villages, towns, cities and regions across the UK, engaged in activities intended to welcome people seeking sanctuary. They also contribute towards wider movement building through partnership work, advocacy and campaigning initiatives. This grant supports City of Sanctuary to enhance organisational sustainability and strengthen its network to build a welcoming environment for people who migrate to the UK.

Runnymede Trust

Grant amount: £240,000

Grant duration: 48 months

Project: Policy work to improve race and migration outcomes in the UK

Description: Runnymede Trust is the UK's leading race equality think tank, which seeks to inform public and policy debates on race equality, migration and integration. This grant contributes to core salaries to support greater collaboration between the migration and race equality sectors. This work will drive forward advocacy, policy and campaigns on migration,

integration and racial justice, improve framing and messaging for different audiences, and expand Runnymede's partnerships.

The Institute of Race Relations (IRR)

Grant amount: £128,000

Grant duration: 48 months

Location: London

Project: Building communications capacity of the Institute of Race Relations

Description: The Institute of Race Relations (IRR) is an anti-racist think tank that produces research and analysis to inform the struggle for racial justice in Britain, Europe and internationally. This grant supports the role of a dedicated Communications Worker in order to continue mobilising IRR's core support base, expand reach to younger audiences, and grow IRR's wider impact.

The Refugee Asylum and Migration Policy (RAMP) Project

Grant amount: £120,000

Grant duration: 36 months

Location: London

Project: Supporting Conservative MPs to engage constructively on migration policy

Description: The Refugee and Migrant Policy (RAMP) Project is an independent not-for-profit organisation. They help political leaders to think more deeply and to collaborate more widely on migration, asylum and integration issues. This grant supports RAMP to constructively engage with an additional Conservative MP on issues of migration and asylum to increase their ability to influence policy debate.

The Unity Project

Grant amount: £105,000

Grant duration: 36 months

Location: London

Project: Tackling the inequality and discrimination behind the 'NRPF' policy.

Description: The Unity Project support people affected by the 'no recourse to public funds' (NRPF) policy to remove the NRPF condition from their leave to remain status. They run weekly casework sessions, provide appointments and workshops to help people make 'Change of Conditions' applications and pursue lasting policy change and strategic litigation. This grant supports The Unity Project to continue tackling the inequality and discrimination behind the NRPF policy for people who migrate to the UK, working towards ending the policy.

Arts Access and Participation Fund

The Arts Access and Participation Fund addresses inequalities of opportunity to access and

participate in the arts. We want to support change in the way the arts are created, presented, accessed and experienced.

Amal

Grant amount: £75,000

Grant duration: 18 months

Location: London, West Midlands, Yorkshire and the Humber

Project: Amal Connects

Description: Amal supports and develops creative endeavours that increase understanding of and belonging among Britain's Muslim communities. This grant supports a new programme, Amal Connect, that emphasises additional local support from a coordinator and the creation of hubs, initially in Birmingham and Bradford. The new post will enable deeper collaboration and engagement between cultural organisations and Muslim communities and organisations.

Attitude is Everything

Grant amount: £300,000

Grant duration: 48 months

Location: UK Wide

Project: Attitude is Everything: Core funding

Description: Attitude is Everything improves disabled people's access to live music. This grant is part of four-year continuation funding including ongoing support for two key staff roles. This will underpin the organisation's ability to deliver and further develop their key sector support role for the live music industry, ensuring Deaf and disabled experience is at the heart of an accessible reopening for music and other arts events.

The Garage

Grant amount: £345,000

Grant duration: 36 months

Location: East of England

Project: The Garage Youth Inclusion Programme

Description: The Garage is a hub and charity for performing arts in Norwich. This grant provides core support for the Youth Inclusion Programme in Norwich and King's Lynn, including a new approach to community work which will feed into the broader organisational development of The Garage's approach to Diversity, Equity and Inclusion, co-creation and learning and evaluation.

Transform

Grant amount: £250,000

Grant duration: 36 months

Location: Yorkshire and the Humber

Project: The Collective at Transform Festival

Description: Transform creates biennial festivals and citywide cultural takeovers from their base in Leeds city centre. This grant supports a three-year programme through which Transform will embed co-creation with young people into their organisational model and across their biennial festivals in 2021 and 2023. 'The Collective' will focus on creative and personal development for 16-21-year olds, offering resources and support to commission, curate and create their own projects through cross-art form cultural experiences.

Yorkshire Sound Women Network (YSWN)

Grant amount: £70,000

Grant duration: 24 months
Location: Yorkshire and the Humber
Project: Permission to Play

Description: Yorkshire Sound Women Network (YSWN) enables the artistic and technical development of women and gender minority people through access to resources, skills-sharing, and creative opportunities. This grant supports YSWN to create more opportunities for women and gender minority people to creatively engage with sound and music technology. The focus of this work will be the continued development of grassroots community-led groups; online workshops and networking sessions; a skills development offer for its pool of freelance Associates; and increased evaluation measures.

Amanda Walters

Grant amount: £15,575
Grant duration: 6 months
Location: UK wide
Project: Building a national movement of cleaners

Description: Amanda Walters is a community campaigner who wants to create a broad alliance of trade unions and community organisations to create change for cleaners in the UK. This grant supports the early stages of the UK's first Labour Community Alliance for the cleaning industry in the UK.

Happy Smiles Blog CIC

Grant amount: £15,640
Grant duration: 12 months
Location: North West
Project: Realise Your Potential

Description: Happy Smiles is a profit-for purpose training provider, inspired and driven by disabled young people. This grant supports Happy Smiles to build upon their work in schools to offer bespoke support for young disabled adults who are transitioning from education, either looking for employment opportunities or otherwise don't know what to do. They will be testing their project idea by trialling it with a group of local young adults in Wigan.

Ikram Hirse

Grant amount: £15,650

Project: SIDQ - connecting your story with your community

Description: SIDQ is a community platform developed by Ikram Hirse that amplifies and supports Islamic institutions by cultivating safe, transparent and sustainable communities through showcasing available Islamic provisions and services. This grant supports the development of the platform as a centralised digital community hub to provide a safe space for individuals to find the services they need.

Inclusion Labs

Grant amount: £15,075

Grant duration: 8 months

Location: UK wide

Project: Transforming schools into inclusive communities for students from underrepresented groups

Description: Inclusion Labs creates impactful programmes that work towards embedding diversity, equity and inclusion into young people's educational, cultural and personal development. This grant supports Inclusion Labs Schools develop a programme to make schools more inclusive for every child, particularly those from underrepresented groups or lower socio-economic backgrounds.

Michael Ojo

Grant amount: £15,575

Grant duration: 12 months

Location: London, South East, Northern Ireland

Project: African roots of vocal science and music therapy

Description: Michael Ojo is an artist, creative director and teacher. This grant supports Michael to develop and pilot a new music curriculum through 20 music masterclasses for professionals, academics and students in music schools. It teaches African-American vocal training, its influence on contemporary music and roots in music therapy. This pilot will help test, adapt and improve the curriculum, solidify school participation, and help strengthen the case for accreditation.

Noah Parslew

Grant amount: £15,700

Grant duration: 6 months

Project: Speak-Easy: A communication aid that gives the user a voice

Description: Noah Parslew is developing Speak-Easy, a predictive text-to-voice application designed to help people communicate, enhancing their quality of life and independence. This grant supports the development of an online version of Speak-Easy, and to test its use in schools as a way to support young people with speech, language and communication needs.

Pell Ensemble UK, U Can Too, and Emma McFarland

Grant amount: £15,123

Grant duration: 11 months

Location: London, South East

Project: Move & Code: teaching computing fundamentals through movement and dance

Description: Pell Ensemble is a creative and collaborative company making digital experiences that connect people to themselves and the world around them. This grant supports Pell Ensemble to collaborate with U Can Too and Emma McFarland to develop a

programme that combines dance and digital to test how to teach computer fundamentals in a new and engaging way.

Plant Paradise Ltd

Grant amount: £15,150

Project: Plant Paradise

Description: Plant Paradise aims to connect volunteers with planting projects on a global scale. This grant supports the development of the Plant Paradise online platform that will connect volunteers with planting projects, to help accelerate the much-needed restoration of our natural world. The platform will make it easy for organisations to advertise planting events and simple for volunteers and groups to search for local projects to join.

Polly for Women CIO

Grant amount: £15,400

Grant duration: 3 months

Location: North West

Project: Pilot for Polly: The UK's first helpline for women

Description: Polly for Women aims to provide a support helpline and webchat for women and girls in the UK. This grant supports a three-month pilot of Polly in Greater Manchester which will provide a safe space run by and for women, and information about services supporting women's safety and needs.

Several Seats

Grant amount: £15,575

Project: Several Seats mentorship scheme

Description: Several Seats aims to promote mental health in women within the community that identify as minority ethnic. Their mission is to inspire, empower and educate in order to improve the community and bring about a more united, inclusive society. This grant supports a mentorship scheme which will champion young BAME women facing complex academic and professional transitions within the mental health sector. The scheme will enable mentees to lead community and institutional change in mental health services and students and aspiring psychologists will be offered a range of opportunities for learning, development and networking.

Winnie Ssanyu Sseruma

Grant amount: £15,575

Grant duration: 12 months

Location: London, South East

Project: Black Health Activists Mentoring & Empowering Network (BHAMEN)

Description: Founded by Winnie Ssanyu Sseruma, the Black Health Activists Mentoring & Empowering Network (BHAMEN) is a new organisation that aims to develop a network of Black health activists to empower communities to access health services. This grant supports the development of the first BHAMEN network in London and the South East, with the intention of rolling out to the rest of the UK, alongside development of an online platform.

Zareen Ali

Grant amount: £15,575

Grant duration: 8 months

Location: London

Project: Starting an antiracist school

Description: Zareen Ali is using her experience from tech, education and psychology to carry out research that will form the basis of a new anti-racist school. This grant supports Zareen to co-design research with young people and communities in order to inform and shape plans for an anti-racist school in Newham, East London.

Covid Response Fund

Anti Racist Cumbria

Grant amount: £20,000

Grant duration: 3 months

Location: North West

Project: Covid-19 Emergency Funding

Description: Anti Racist Cumbria is a voluntary organisation created in response to the Black Lives Matter movement. They exist to identify, challenge, tackle, and end racism in Cumbria through practical projects that deal with the root causes of systemic racism in schools, businesses, communities and wider organisations. This grant provides core support to aid the organisation in dealing with the challenges posed by Covid-19.

Ardent Theatre Company

Grant amount: £20,000

Grant duration: 6 months

Location: London, South West

Project: Covid-19 Emergency Funding

Description: Ardent Theatre Company produce theatre, career training and mentorship programmes, providing a platform for theatre industry voices and online resources. Their aim is to make theatre a place where no one feels like an outsider, welcoming people whose voices are unheard and stories untold. This grant provides core support to aid the organisation in dealing with the challenges posed by Covid-19.

Bail for Immigration Detainees (BID)

Grant amount: £27,500

Grant duration: 6 months

Location: UK Wide

Project: Covid-19 Emergency Funding: Supporting volunteer caseworkers

Description: Bail for Immigration Detainees (BID) provides legal advice and representation in bail matters to people detained under immigration powers. They undertake substantive legal casework for people who are facing deportation and use this to provide an evidence base for their policy work in their campaign for the abolition of immigration detention. This grant supports BID to invest in secure technology, hardware and training to allow them to bring back volunteers who are integral to the organisation's advice provision.

Black Lives in Music

Grant amount: £19,500

Project: Covid-19 Emergency Funding

Description: Black Lives in Music (BLiM) is dedicated to galvanising awareness and precipitating improvement in diversity at all levels in the UK music industry, specifically in the areas of Classical and Jazz in conservatoires, orchestras and professional ensembles. They stand for equal opportunities, and specifically for Black people to be able to work successfully in the UK music industry without being the subject of discrimination. This grant provides core support to aid the organisation in dealing with the challenges posed by Covid-19.

Body & Soul

Grant amount: £20,000

Grant duration: 3 months

Project: Covid-19 Emergency Funding

Description: Body & Soul supports children, young people, and families whose lives have been affected by childhood adversity and trauma. It uses a 'whole person' model of care rooted in a strengths-based approach that nurtures connection, healing and growth. This grant provides core support to aid the organisation in dealing with the challenges posed by Covid-19.

CARAS

Grant amount: £20,000

Grant duration: 6 months

Location: London

Project: Covid-19 Emergency Funding

Description: CARAS is a charity that supports refugees and asylum seekers in London to learn English, build supportive networks and access their rights and entitlements. Based in South London, they support separated children and young people who are seeking asylum (80%) and adult women (20%), with either unsettled or recently secured immigration status to integrate and live independent lives. This grant provides core support to aid the organisation in dealing with the challenges posed by Covid-19.

Chartered College of Teaching

Project: Covid-19 Emergency Funding

Description: The Chartered College of Teaching is the professional body for teachers. They celebrate, support and connect teachers to take pride in their profession and provide the best possible education for children and young people. This grant provides core support to aid the organisation in dealing with the challenges posed by Covid-19.

Chinese Community Centre

Description: The Chinese Community Centre is London's centre for the preservation and promotion of Chinese culture, arts and identity. They aim to help the Chinese community to integrate into the UK at the same time as celebrating Chinese heritage. This grant provides core support to aid the organisation in dealing with the challenges posed by Covid-19.

Circles South West

Description: Circles South West is an independent charity whose purpose is to reduce the risk of (re)offending by people who have sexually offended or have displayed harmful sexual behaviour. The organisation intends to sustain and grow their service across the South West, consolidate delivery practice and develop a trading arm to provide training and consultancy. This grant provides core support to aid the organisation in dealing with the challenges posed by Covid-19.

Digitspace

Description: Digitspace provides British Sign Language (BSL) guided tours in national museums and galleries, covering themes around contemporary art, street art and architecture. They also facilitate art guide training for local deaf people and awareness workshops for curators and stakeholders in the North East. This grant provides core support to aid the organisation in dealing with the challenges posed by Covid-19.

Disasters Emergency Committee (DEC)

Description: The DEC is made up of 14 member charities who are experts in humanitarian aid and specialise in different areas of disaster response. They come together to speak in one voice and make fundraising more efficient when the DEC launch an appeal. When large-scale disasters hit countries without the capacity to respond, the DEC brings members together to raise funds quickly and efficiently. This grant constitutes Paul Hamlyn Foundation's contribution to the DEC's Coronavirus Appeal for emergency response in India.

Description: The Edinburgh Festival Fringe Society (EFFS) is the organisation that underpins the Edinburgh Festival Fringe. Their three core objectives are to provide support, advice and encouragement to participating artists, producers, venues and professionals;

assist audiences to navigate the festival and its programme; and to celebrate the Fringe worldwide. This grant provides core support to EFFE as the organisation recovers from the impacts of Covid-19, including their major fundraising campaign 'Save the Fringe'.

They are co-founders of the Collective Leadership Group, an initiative that seeks to create greater connection, collaboration and innovation across capacity-building and enterprise support providers for the UK social sector. This grant supports the appointment of a Community Lead who will map sector provision, support learning and insight, and grow membership.

Description: Heart and Sound offers a range of creative and youth work activities for young people in Dunfermline, with a particular focus on music. This grant provides core support to aid the organisation in dealing with the challenges posed by Covid-19.
